Type of Fee applied	When Fee applies
Resident fee	If the deceased was a Huntingdon resident.
	If the deceased was a Huntingdon resident that moved to residential care within the last 5 years.
District Resident	If the deceased lived within the District of Huntingdon but not in Huntingdon Town.
Non-resident	If the deceased lived outside of Huntingdon District.

Pre-Need Purchases

Type of Fee applied	When Fee applies
Resident fee	If the person purchasing the grave rights is a Huntingdon resident.
District Resident	If the person purchasing the grave rights lives within the District of Huntingdon but not in Huntingdon Town.).
Non-resident	If the person purchasing the grave rights lives outside of Huntingdon District.
